## President's Message

The meeting took place at BEES headquarters on Waverly Ave in Patchogue!! It was an exceptionally light turn out and we hope to see many of you at future meetings!

The Supreme Court decision on the Janus case has been decided and issued. In a 5-4 decision, with Justice Alito writing the majority opinion, the court ruled in favor of Janus, thus eliminating agency fees. Mr. Janus is a mem-

ber of AFSCME, and works in the Illinois Department of Health Care. As a result of this case, all members reap the benefits of collective bargaining, but only those who **actively sign on** to union membership would pay their share for those benefits! All members still benefit from union activism relating to job/ working conditions and job /benefit improvements.

Anyone who worked in education in the early 50's and 60's knew how difficult it was to get to the point where current contracts are today! It took lots of time, energy, money, training, smart contract bargaining to get to a reasonable salary and benefit level. This case cannot stop our progress. Every day there is further erosion of our rights as public employees and it is very shocking that the 1<sup>st</sup> amendment was used against membership in a union. Justice Alito writes, "public employees are forced to subsidize a union, even if they choose not to join and strongly object to the positions the union takes in collective bargaining and related activities." Further he states, "We conclude that this arrangement violates free speech rights of non-members by compelling them to subsidize private speech on matters of substantial public concern." REALLY!!!

This decision could seriously impact all our union's ability to fairly and politically represent its members. "Members and money are power in politics," says Terry Moe a Stanford Political Science Professor, and "this will weaken the teachers unions nationwide as a political force." Don't let this happen! We can and will support our union because without it, ultra-conservative groups win and our advocacy and status can be diminished! Locals receive support
