Wouldn't it be wonderful to have a breakfast out together as we have done in previous years to welcome our new retirees? We hope that with the increasing availability of vaccine supplies, everyone seeking vaccinations has found appointments, and that it will be much safer to gather inside this fall when most people are inoculated.

#### SOME GOOD NEWS!

The NY State budget has just passed with increased funding for public education. That is very good news for our grandchildren in public schools, and for our still working colleagues who would have faced steep cuts and layoffs if the federal American Rescue Act and the NYS budget agreement were not achieved. For retirees, the NYS Medicare Premium and IRMAA reimbursements that our school districts send to us were approved for another year. Every year our union lobbies on our behalf to keep those important reimbursements in place.

We hope to see the removal of the \$10,000 cap on State and Local Tax deductions (SALT) by Congress in this year's federal budget which will give even more relief to taxpayers in NY and on LI in particular. Our VOTE COPE dollars keep the pressure on our legislators to protect all these essential protections, and others like Social Security, Medicare, and Medicaid fully funded.
